



February 5th Meeting Highlights

Public Works Department

The Board approved to sign the 2023 Township Highway System Mileage Certification for 93.117 Canton Township miles as provided by the Stark County Engineer.

The Public Works Director updated the Board on a grant that was applied for up to \$75,000 through the H2Ohio Chloride Reduction Grant Program to potentially purchase technology for dump trucks to make guided decisions on the use of salt on roadways.

The Board approved a letter and Resolution requesting participation in the Community University Education Council of Governments to begin purchasing road salt at a discounted rate. The Stark County Engineer is expiring their own purchasing program effort, will be joining this program, and Canton Township intends to do the same.

2023/2024 winter storm snow/ice removal costs are currently all-in at \$143,600 vs \$193,000 this time the year prior.

The Public Works Director gave updates on the Residential Yard Waste Site planning for 2024. Look for more information to come out shortly on this new program.

Board approved the Public Works Director to sign a contract with Bull Country Compost LLC for future yard waste hauling at a \$5.00 increase per container above 2023 costs.

Board approved to sign the fireworks contract for 2024 Community Day.

Received an update on the amphitheater construction timeline from the Public Works Director.

The Board approved the 2024 Easter Egg Hunt for the community at Faircrest Park.

The Board approved to hire Shawn Parcell as a Special Operations Trainer at a contracted monthly rate.

The Board authorized the Fire Chief to apply for an AFG Grant with an intended use of replacing equipment and gear.

General News

The Elected officials attended the 2024 Ohio Township Association Conference and Trade Show last week. Congratulations to Trustee Chris Nichols as he was elected to a four year term to serve on the OTA Board of Directors.

Requested township legal counsel prepare formal steps to take for the Board to consider placing onto the General Election ballot an opportunity for Canton Township to become a Limited Home Rule township as recognized in Ohio Revised Code following State of Ohio legislative action. This option will provide the township and residents of the township with expanded options to help address many everyday concerns. More information will be communicated should this be pursued.

Received update on Stark County Sheriff dedicated patrol inside Canton Township paid by the General Fund.

The Board authorized to list items from the Community Center cafeteria for sale on GovDeals.
