#### 2023 Recycling - Yard Waste



Starlk-Tuscarawas-Wayne Recycling District

Canton Township was awarded a grant in 2023 in the amount of \$40,300.00 for operation of our yard waste site. This grant money is used to handle the expenses of hauling the yard waste to a compost facility. Our site was opened on April 1<sup>st</sup> 2023 and closed on December 31<sup>st</sup> 2023. During that period, 310 loaded dumpsters were hauled from our location to Bull Country compost. The monthly breakdown is as follows:

As shown, the expenses for hauling were much greater than the grant amount in which we were awarded. The Recycling District has agreed to reimburse us for all expenses incurred with the hauling during the 2023 season.

Along with the expense of hauling, which is covered with a grant from the Stark-Tuscarawas-Wayne Recycling District, the Township incurs costs for labor, fuel, equipment, and repairs to equipment for the loading of waste material. These expenses are covered by the Public Works Department and paid for out of the Road Department budget. In 2023, those expenses came in at \$12,172.26.

## 2023 Recycling – Household



Take advantage of services, facilities, programs, and events for the recycling and safe disposal of a wide range of household items. Here is how you can reduce waste in our local landfills while helping to protect the community and environment.

The Recycling District coordinates and oversees:

- Recycling drop-offs in Stark, Tuscarawas, and Wayne Counties for residentially generated recyclables only
- Yard waste drop offs at any of our approved sites for residentially generated material only
- Year-round collection of household hazardous waste at the Canton Recycling Center

### 2023 Snow/Ice Mitigation

The 2023-24 winter season is hopefully almost behind us. We have kept the streets of Canton Township safe for the traveling public. The crew of eight is on call 24 hours a day 7 days a week throughout the winter season for when snow and ice appear. None of the guys can stray far from home because you never know when they will be needed. Watching the weather forecasts throughout the season is a constant task.



First date out for the 2023/2024 season was on November 9th, 2023. Since then, we have been out a combined total of 20 times between salting and plowing.





- $\succ$  1,744 tons of salt have been used
- Total cost of salt used for the 2023/2024 season so far has been \$103,846.24
- The Public Works Department personnel have been out a total of 20 times
- $\succ$  17 events were just to apply salt
- 3 events were to plow and apply salt
- Personnel put in a combined total of 753 hours for snow and ice mitigation so far
- ➤ Labor cost of \$25,306.00

### 2023 Road Resurfacing

In 2023, the Township again bid out our proposed paving project. The project was a bit unique due to a Canton City Water Project in the southern end of the Township. A large area on the Southwest side of Cleveland Ave between Faircrest and Carnwise and the entire Southeast side of Cleveland Ave from Faircrest to  $32^{nd}$ St. had city water installed. The water project was funded by a grant from the EPA and part of that grant included re-paving one half of every street that the new water system followed. For the Township, this meant that we were going to get one half of each street paid for and we only had to cover the other half. What a deal! If it wasn't for the water project grant, there is no way that the budget would allow for the amount of paving that was done.

Included in the 2023 paving was the 2022 paving project which was granted an extension by the Board of Trustees in 2022 due to extremely high prices and labor issues with the contractor.

Northstar Asphalt Inc. had been awarded the 2022 paving project for \$628,488.00 which covered 2.91 miles of streets.

Northstar Asphalt Inc. was again the winneing bidder for the 2023 paving project in the amount of \$502,937.63 and covered 6.78 miles of streets. Ahead of proposed paving, the Public Works Department inspected and replaced any questionable culvert pipes,d catch basins, and trimmed trees back from the streets.

#### 2023 Road Repairs

Along with the 2023 Asphalt resurfacing project there were many areas where large area patching was performed. Those areas are listed below with the cost associated with each.

Large area patching is done every year on different streets in problem areas to help extend the service life of the pavement. This type of patching usually requires the pavement to be milled, tack applied, and new asphalt laid down and compacted. Problems that occur that require large areas to be patched are:

- > Raveling
- > Depressions
- > Potholes
- Alligator Cracking
- Longitudinal Cracking
- Block Cracking
- Edge Cracking
- Asphalt Upheaval

#### 2023 Stormwater Management

Our Township's Stormwater System is maintained and overseen by the Canton Township Public Works Department. Finding and correcting problems and issues with the storm system are found by, but not limited to the following ways.

- Service requests from residents
- Issues observed by Township employees
- Other agencies reporting issues

#### Summary-

The National Pollutant Discharge Elimination System (NPDES) small municipal separate storm sewer system (MS4) general permit required the development and implementation of a Storm Water Management Program (SWMP) that satisfied the appropriate water quality requirements of the Ohio Revised Code (ORC) 6111 and the Clean Water Act. This must identify and describe the best management practices (BMPs) the MS4 has selected to address in the permit. The six Minimum Control Measures (MCMs) were selected by the MS4 in light of local water quality issues. The six MCMs are:

- 1. Public Education and Outreach
- 2. Public Participation and Involvement
- 3. Illicit Discharge Detection and Elimination
- 4. Construction Site Runoff Control
- 5. Post-Construction Runoff Control
- 6. Pollution Prevention/Good Housekeeping for Municipal Operations

Canton Township has a Memorandum of Understanding (MOU) with Stark County Soil & Water Conservation District for Technical Assistance. The MOU, signed January 2022, is for a two-year period which expires in April of 2024. For the sum of \$4,000.00 each year Stark Soil will assist Canton Township with the six MCMs, and reporting required in our annual EPA NPDES small MS4 general permit report.



### 2023 Stormwater Management Cont.







- $\succ$  75 Catch basins cleaned
- $\succ$  50 Catch basins repaired
- $\geq$  30 New catch basins installed
- $\geq$  8 old catch basins replaced
- 2,809 feet of culvert pipe was either installed new, old pipe replaced, or repaired
- 180 feet of culvert was flushed due to a blockage
- ▶ 9,032 feet of roadway ditches were cleaned and reshaped.
- 2,000 feet of roadway were bermed for proper water runoff



### 2023 Road Safety and Maintenance

A duty of the Public Works Department is to keep the streets safe for the traveling public. Part of that duty is to keep the streets and road right of ways clear of trees, dead animals, trash/debris, and discarded tires.

- A total of 44 trees were removed from Township streets or the right of way due to storm damage or safety issues
- 6 trees were removed from Faircrest park due to storm damage by the Public Works Department
- ➤ 4 trees were removed from Hillcrest Cemetery
- Numerous trees were trimmed back from the roadway
- 22 deceased animals were picked up from the street and disposed of



 251 tires were picked up from roadside ditches and recycled through a grant from the Ohio EPA

## 2023 Road Safety and Maintenance Cont.



- 44 different times to clean up trash and debris from the road, right of way, or ditch
- No tonnage totals are available as most items are disposed of with our regular trash collection service
- Items picked up include furniture, household trash, building materials, and yard waste

The Public Works Department in conjunction with Stark-Wayne-Tuscarawas Recycling District applied for and received a grant from the Ohio EPA. This grant will provide the pick-up (from our location) and proper recycling of up to 5,000 illegally dumped tires from Township streets, right of ways, and ditches. Canton Township has partnered with neighboring Townships to accept their tires at our facility for storage and centralized pick up for the hauling company.





### 2023 Road Safety and Maintenance Cont.

Another part of our road safety and maintenance is the upkeep of signage on the Township streets and the streets of the Village of Meyers Lake. We handle regulatory, warning, lane control, information, parking control, street name, school, littering/recycle, park, road, and object marker signage. We follow the MUTCD guidelines and the retro-reflectivity laws. Signage is a never-ending job. There is always signage to update, or replace due to age or accident. Canton Township has switched over to using a stronger galvanized u-channel sign post which holds up better in the wind and looks better due to not rusting after installation.



- > 147 sign issues were handled during 2023
- ➢ 92 were new signs and new posts
- 55 were repairing/straightening the old sign or post



- ➢ 35 Road opening Permits were issued in 2023 for various contractors and utility companies
- ➢ Total of permit fees collected was \$7445.00

#### 2023 Parks & Cemetery

- > Trash was checked and collected a total of 127 times between both parks
- ➢ Both Parks were mowed a total of 20 times each
- Administration was mowed a total of 15 times
- Hillcrest Cemetery was mowed 15 times
- > The flag box was emptied 33 times
- A small light display was at Faircrest Park during the Holidays
- > The playgrounds at both parks were inspected 25 times
- Clean-up of Hillcrest Cemetery continued and debris hauled out

### 2023 Community Day









- Community Day was held on June 24<sup>th</sup>, 2023
- LED Transportation provided shuttle buses to and from the parking lot at Faircrest Elementary school to the park
- 7 food vendors participated to provide food to attendees: Moonshine Q BBQ, JD's Gourmet Dogs, French Fries, Three Lil Piggies BBQ Food Truck, Bomb Tacos, Schoups Ice Cream, and Kona Ice
- Live entertainment was provided by Sounds From the Cellar and Gary Prisby
- Fireworks display was provided by Starfire Corporation
- Boy Scout Troop 250 participated by helping out with trash and cleaning
- Numerous area groups/organizations set up booths to display their products or showcase what they do in and around the community
- Approximate number of attendees was 3000
- Collected donations in the amount of \$30,350 from area businesses and residents
- Township elected officials, Public Works Staff, Fire Department Staff, and Office staff were all in attendance.
