The Public Works Director updated the Board that new playground equipment at Faircrest Park has begun and should be completed by the end of next week (weather permitting).

Public Works Department

The Public Works Director submitted the 2025 Asphalt Paving Project and the 2025 Chip Seal Project. Both projects have been bid out and contracts were signed for the following:
