Zoning Department

As of the May 16th meeting, 39 letters have been sent to notify property owners of high grass.

The Board approved the Fiscal Officer to to a letter to the Stark County Auditor requesting a lien on the tax duplicate for lawn maintenance/ high grass on (8) parcels: 1308052, 1313128, 1312457, 1305320, 1302711, 1302713, 1315065, and 1312424 totaling: \$4,800.

The Board declared the following property as a nuisance as deemed by the Zoning Director, and ordered it abated per Ohio Revised Code 505.173 and/or 505.86 and or 505.87- 403 Baumford Ave SE for trash and debris.

The Board of Zoning Appeals will conducted a public hearing on June 12th at 7:00 pm

- Parcel No. 1308124-Shepler Church Ave SW- B2 Neighborhood Business District. Applicant is seeking a 30-foot variance to the east side yard setback for a proposed commercial storage building in a B2-Neighborhood Business District. This property is located in the Southeast Quarter of Section 19 in Canton Township, Stark County, Ohio.
- 119 46th ST SW- RR Rural Residential District. Applicant is seeking a 30-foot variance to the front yard setback for a porch roof in a RR- Rural Residential District. This property is located in the Southeast Quarter of Section 28 in Canton Township, Stark County, Ohio.
- 3002 Allenford Dr SE- RR Rural Residential District. Applicant is seeking a variance to exceed the square footage of the primary use structure with unattached accessory buildings in a RR- Rural Residential District. This property is located in the Southeast Quarter of Section 21 in Canton Township, Stark County, Ohio.

General Updates

The Board approved the Fiscal Officer to sign the Ohio Liquor Permit for 2734 Cleveland Ave S.


The Board accepted a \$20 donation from Greg & Deborah Bigelow to the Community Center in lieu of attending the pancake breakfast.

The Board reviewed quotes to replace the Community Center door admittance system to enable remote access control.

Approved a month to month agreement addendum for Bridge Point's temporary utilization of the Learning Center space, for use by a part time coordinator, with monthly rental fee while the organization searches for a

new location.

The Board approved a resolution to support the creation of a community reinvestment area known as Raff/ Gambrinus/ Faircrest CRA. This was sent to the County Commissioners and has since been approved.



Stark County Overdose Awareness Day is August 12

In 2022, approximately 156 Stark County residents were among the 4,984-plus Ohioans who lost their lives to overdose. That's why the Stark Overdose Awareness Committee will bring people from all backgrounds together to unite under a common cause: Calling attention to the ongoing overdose crisis and remembering those affected without shame or stigma. The committee will host an Overdose Awareness Day event on Saturday, August 12 from 9 a.m.-12 p.m. at Centennial Plaza in downtown Canton. Canton Township residents are invited to attend.

Activities and resources will be available for youth, older adults, Veterans and women. Some of the activities being planned for the morning include:

- Drum therapy from Warrior Beat, a non-profit charity that helps military veterans who suffer from PTSD, anxiety, depression, thoughts of self-harm and suicide, substance abuse and other mental and physical challenges
- Yoga for 12 Step Recovery, which combines the practical tools of 12 step programs and cognitive addiction methodologies with the ancient art and science of yoga, neuroscience and trauma healing
- · Free haircuts
- · Health services from the Stark County Health Department's mobile integrated care unit "Driving Towards A Healthy Community"
- · Naloxone distribution provided by Canton City Public Health
- · Linkage to care provided by AVO Behavioral Health and Recovery Center

The Stark Overdose Awareness Committee is made up of local and regional agencies including AVO Behavioral Health and Recovery, Canton City Public Health, HEALing Communities Study, Let's Get Healthy Cleveland, Massillon City Health Department, Metamor5sis, Millennium Health, Stark NAACP, OhioCAN (Change Addiction Now), Stark County Health Department, Stark County Mental Health & Addiction Recovery, and Veterans Services Commission.
