

# January 22nd Meeting Highlights

#### <u>Fire Department</u>

The Board approved hiring three full-time and three part-time CTFD personnel. The three full-time new hires are replacement positions.

### Public Works Department

The Public Works Director provided an update on winter roadway maintenance for the season. So far the Public Works Department has been out treating roadways for snow and ice a total of 33 times. To date labor, equipment, fuel and salt expenses are approximately \$281,000.

The Board approved the township road mileage certification for a total of 93.117 miles.

The Board approved the 2025 Storm Water Management plan for the township as well as CTFD and Public Works/ Administration.

The Public Works Director updated the Board on early bookings for park pavilion rentals. Faircrest Park pavilion is already booked for every Saturday in June. The Board accepted two weeks of rental fees for \$450.


\*SAVE THE DATE \* The township Easter Egg Hunt will be held on Saturday, April 12th at Faircrest Park. More details to come.

### <u>Yard Waste</u>

The residential yard waste site will reopen on April 1st. The site will expand the days of operation to seven days a week from 8am-7pm. The annual fee for a key card is \$40 (no increase from last year). If reusing a key card from last year, user can pay by phone or mail a check payable to Canton Township (please include name on card and phone number), or stop in township administration M-F from 8am-3pm. New users will need to stop in the office to sign the registration form and verify residency. This site is for residents of Canton Township, Pike Township, and Village of East Sparta. For questions, please call the township office (330) 484-2501.

The Board approved to sign the contract for yard waste hauling with Bull Country for \$175 per container (same cost as 2024).

### Zoning Department

The Board declared the following property as a nuisance as deemed by the Zoning Director, and order it abated per Ohio Revised Code 505.173 and/or 505.86 and/or 505.87.4. 5011 Cardell Ave SW for trash/ debris.

The Board approved the Fiscal Officer to sign a letter to the Stark County Auditor requesting a lien on the tax duplicate for board-up assessment on (1) parcel #1301591 for \$524.00.

Due to a retirement, an alternate position is available on the Zoning Commission Board. The Zoning Commission is comprised of five township residents and two alternates appointed by the Board of Trustees. This is a quasi- legislative body to establish and amend the Zoning Resolution and Township Zoning Map.
