Fire Department



Welcome to Canton Township Fire Department! Three new part-time firefighters were sworn in at last Tuesday's meeting by Trustee Nichols. We would like to welcome Tommy Gibbs, Alex Wilson, and Seth Falcone. Best wishes on a long and healthy career.

The Board heard safety concerns regarding pine trees on Station 1/Fire Admin/Community Center property due to storm damage and Board agreed to have the trees removed.

Public Works Department

The Public Works Director updated the Board that after a \$3,000 engine repair, the street sweeping unit is back in operation.

A total of 12 flags were stolen along Faircrest Street SW that were on loan to the township from Operation Flags of Freedom. Young Trucks has volunteered to reimburse Operation Flags of Freedom for the cost to replace the flags.

The Board was updated on price quotes for various flag/ banner/ holiday signage ideas on Cleveland Ave.

The Board agreed to have lighting on a recently vacated portion of Navarre Rd SW turned off and removed from billing via AEP.

Zoning Department

The Board declared the following properties as nuisances as deemed by the Zoning Director, and ordered them abated per Ohio Revised Code 505.173 and/or 505.86 and/or 505.87 and the Canton Township Property Maintenance Code. 3936 4th St NE and 1484 Valentine Cir NW both for trash and debris.

The Board approved the Fiscal Officer to sign letter to Stark County Auditor requesting a lien on the tax duplicate for lawn maintenance/high grass nuisance assessment on 10 parcels: 1302711, 1307798, 1380055, 1380054, 1380056, 1303049, 1315001, 1302896, 1306954, 1400957, totaling \$5,700.00
