Public Works Department

The following roads will be marked as no parking for Community Day, June 25th from 8:00am through 11:00 pm. (39th St SW, Davis St SW between Springvale Ave SW and Monica Ave SW, Monica Ave SW between Davis St SW and Faircrest St SW and Springvale Ave SW between Faircrest St SW and Davis St SW).

The residential yard waste site is open on Wednesday, Saturday, and Sunday from 9:00 a.m.- 7:00 p.m. The Board is closely monitoring the expenses against the \$45,100 grant funding amount from Stark Tuscarawas Wayne Recycling District. When funds are exhausted the yard waste site will close.

As of the June 21st meeting, the year to date hauling expense was \$7,650.

The Board approved the promotion of Public Works employee Doug Weaver to the position Road Forman. Congratulations Doug!

Northstar Asphalt Inc. was awarded the 2022 Asphalt Paving Project at a cost of \$628,488.00. The project went through two rounds of competitive bidding by contractors. The first round of bids were all rejected due to the project cost being well over 10% of our engineers estimate for the project. After rejection our engineers estimate was adjusted using the inflated material costs. The results of the second round of competitive bidding came in under our estimate but still at a much higher cost than ever before.

For comparison:

Last year, 2021, we paved 6.5 miles of road for \$776,204.80 or \$119,416.00 per mile of road.

This year, 2022, we are going to pave 2.9 miles of road for \$682,488.00 or \$216,720.00 per mile of road.

These figures include: milling/grinding, tack coat, new surface course, traffic control, mobilization, and striping if needed. Additional costs on top of the above pricing include manhole adjusting rings, which we buy separately, updated signage if needed, and any storm culvert repairs that need done prior to the project.

General News

The Board approved \$1,975 for Silco Fire and Security to enhance security efforts following assessment and recommendations.

Zoning Department

The Board approved the Fiscal Officer to sign a letter to the Stark County Auditor requesting a lien on the tax duplicate for lawn maintenance/high grass nuisance assessment on (15) parcels: 1308052, 1301441, 1301030, 1300489, 1308520, 1307734, 1305099, 1303096, 1301858, 1301859, 1313301, 1307234, 1307235, 1307233 and 1307232 totaling \$7,750.00

As of the June 21st meeting, 70 letters have been sent to property owners notifying them of high grass nuisance.

The Board approved the Fiscal Officer to sign letter to Stark County Auditor requesting a lien on the tax duplicate for nuisance abatement assessment on (2) parcels: 1313116 and 1307234 totaling \$7,321.00.

The Board declared the following property as a nuisance as deemed by the

Zoning Director, and order it abated per Ohio Revised Code 505.173 and/or 505.86 and/or 505.87 and the Canton Township Property Maintenance Code. 2367- 17th St SE for trash and debris.
