- 2022 /23 model, 6000 psi compressor, with a multichambered enclosed fill station that is attached to a three (3) or four (4) bottle 7000 psi cascade system fully enclosed.
- Single phase compliant and entire electrical assembly is UL LISTED.
- Containment and fill capacity for three (3) bottles that can fill independently or simultaneously.
- 13.0 minimum charge rate with 67,000 cubic feet purification system (CGA and NFPA compliant).
- Filter system w/ auto shut-down and reset.
- Automatic condensate dump w/ auto shut-down
- Must meet current standards for; NFPA, OSHA, NIOSH, ASTM, Department of labor at the time of delivery.

Canton Township Bid Contract Requirements

Where the Canton Township Trustees accept a bid but the bidder fails or refuses to enter into a proper contract in accordance with the bid, plans, details, specifications and bills of material within ten (10) days after receipt of notification of award, the bidder shall, except provided in Section 153.54(G), Ohio Revised Code, be liable for the amount of difference between his bid and that of the next lowest bidder, but not in excess of the liability specified in Section 153.4(B) (1)C or G, Ohio Revised Code. Liability on account of an award to the third lowest bidder, or when applicable, the fourth lowest bidder or beyond, shall be determined in a like manner.

To enter into "a **proper contract**" means that within ten (10) days after receipt of the Township's notification of award, the successful bidder shall file with the Township Trustees the following documents exactly in the manner specified:

1. Signed contract, with Certified Corporation Resolution, or notarized statement of partnership or as sole Owner.
2. Certificate of insurance.
3. Current Ohio Workers Compensation Certificate.
4. A statement in accordance with ORC Section 5719.04 filed on Attachment 1 or 2 stating whether the bidder had delinquent personal property taxes at the time of the bid.

Upon failure, within ten (10) days of notification of the award, to file the documents listed above, in the manner specified by the Township, the bidder and/or the surety on the bond shall be liable to the Township under their bid guaranty.

INSTRUCTION FOR SIGNING CANTON TOWNSHIP CONTRACTS

- A. If the bidder is a Corporation, give the State of Incorporation by adding and completing the phrase: "a corporation organized under the Laws of and qualified to do business in the State of Ohio."
