# Q & A with your Fiscal Office

### What are the main sources of revenue for Canton **Township?**

The main source of revenue is from property taxes. Here is a brief overview:

- Our Fire Department is largely reliant upon our fire levies. Stark County and the State of Ohio do not provide any ongoing operational funding. Quite literally: no levy = no fire department. We currently have two levies that are used to pay salaries, purchase vehicles, equipment and maintain our 3 stations. One levy is a continuous levy, while the other levy is on a 5 year renewal. Other funding sources do include EMS billings and grants. Our fire department leadership has been successful obtaining grants from the State of Ohio, FEMA and Firefighter Associations for the purchase of specific equipment or for specific staffing needs for limited time periods.
- Our Public Works Department primarily receives revenue from two sources: Unvoted "inside" millage from your property taxes and a voted levy ("outside" millage). The Public Works Department also receives funds from the State of Ohio: Gasoline Tax, Permissive Tax (from vehicle registrations) and Motor Vehicle Tax (from auto sales). The "inside" millage and levy funds are very restrictive- to be dedicated to only certain expenses and their use is closely monitored.
- Our General Fund receives property tax revenue as well as some funding from the State of Ohio's Local Government Fund (and we are watching House Bill #1 closely as it could drastically alter funding sources and formulas). Other sources of funds include grants, permits, fees, interest, donations as well as park and hall rentals. The General Fund is used to support a variety of expenses related to zoning, park maintenance, cemetery maintenance, portions of township buildings, office equipment, vehicles and administrative salaries.

## My home's value has gone up according to the Stark County Auditor- so I'm paying more for those levies, right?

- Not really. Levy revenue is remarkably stable. The total revenue derived from each property is essentially frozen at the time that the levy goes into effect and valuation increases have little impact. (New construction of residential and commercial properties do contribute to increases). The challenge in our township is that expenses for wages, fuel, utilities, vehicles, equipment, parts have increased and significantly outpaced our income. We have been very resourceful but we will from time to time request an increase...just so we can keep our heads above water and deliver the same level of service to our residents.


### Does our township receive interest or dividend income on its bank balances?

 Yes. Two years ago, we started moving funds to a very safe investment program overseen by the State of Ohio Treasurer's Office (Meeder Investment's Government Insured Deposit Program). Interest rates have increased recently after years and years of abnormally low rates (don't we all know!) and this has benefitted our townshipwe've earned almost \$50,000.00 in interest and much of that has been within the last year. We also keep an operating balance at a local bank but as typical with demand deposit accounts, it pays very little interest.


# Canton Township Electric Aggregation Supplier

Canton Township has chosen Dynegy to be the preferred electricity supplier for you and your neighbors through its Electric Aggregation Program, assuming you are not already contracted with another provider. In November 2015, a majority of the voters approved an electric aggregation program to try and provide cost savings to residents and another "option." With the deal that has been approved, a guaranteed, fixed rate of 6.79 ¢ per kWh through your June 2026 meter read will result. You would continue to receive one monthly bill from your local utility, AEP Ohio. You'll notice that Dynegy would show as a line item for the supply portion on your bill.

If you have any questions regarding the program, call Dynegy at 888-682-2170. Please do not contact Canton Township as we will not be able to provide you with any specifics about your options.

Opt-out letters will be mailed by Dynegy on April 17, 2023. The opt out period ends May 8, 2023. The program begins May 31, 2023, for June 1st meter reads.

AEP Ohio will send you a confirmation letter after your enrollment is finalized. If you don't want to participate, return the portion of the letter you will receive or just call Dynegy at 888-682-2170 by May 8, 2023. If you choose to opt out of the program at this time, or if you choose to leave the program later, you will be served by AEP Ohio under its standard service offer or until you choose an alternative supplier of electric service. If you switch back to your utility, you may not be served under the same rates, terms, and conditions that apply to other customers served by your utility. # FIREDEPT NEWS Fire Department Levy & Operations FAQs



- 1) What is a Mill/Millage? This is \$1 per \$1,000 of a property's taxable value.
- 2) How is my "taxable value" calculated? You take the Auditors market value x .35 x # of mills/ 1,000: Ex:  $$100,000 \times .35 \times 4$ mills/ 1,000 = \$140.00 annually.
- 3) Is the Mill Value the same everywhere? No, the value of a mill is different for each community based on property values. For example: Canton Township 1 mill produces \$412,545 versus Perry Township \$714,668 and Plain Township \$986,375.
- 4) How much is this levy request for? CTFD is seeking a replacement of our five-year renewable levy of 4.0 mill with an additional 1.9 mill totaling 5.9 mill. This will equate to an average increase of \$12.00 month for a median value home of \$105,600.

- 5) When was the last levy increase passed? The last approved increase in funding was this levy in 2013 with a renewal in 2018. This levy is currently still supplying funding based on 2013 property evaluations.
- 6) Are there other funding sources for the department? Yes, there is a continuous levy that was passed in 2001 and the department "soft bills" for EMS calls.
- 7) Does Canton Township Fire Department use volunteers? No, unfortunately the use of volunteer firefighters stopped in 2013. This was due to lack of interest, training requirements, and time constraints. We currently utilize part-time and full-time staff.
- 8) How is the department staffed? We strive to staff

seven personnel a day, two at each of our three stations and one shift commander at station one. This is based on a three-platoon 24/7 schedule. The department operates short staffed 80% of the time meaning that only six or less are on duty/covering three districts.

- 9) Why not hire more full-time personnel? This has become a complicated issue based on several factors: We have had a full-time turnover rate of 73% (11) since 2019. Nine of these left for higher wage departments. Fewer people are entering the profession, which reduces available qualified candidates to fill vacancies. CTFD wages tend to be among the lowest of other county departments.
- 10) What will the increase in funding provide? The department would add three additional personnel to each shift. This funding would provide for maintaining our current levels of daily staffing across operations and administration. Our

- current staff wages would need to be addressed to become competitive with other agencies to achieve workforce retention. The department is currently in need of replacing its fleet of ambulances which have increased in cost by more than 50% (\$150,000 in 2013 to \$300,000). Our current ambulances were originally purchased in 2002 and refurbished in 2014.
- 11) Are you increasing daily staffing? No, the additional full-time staffing would only ensure that we are maintaining our seven-person per day level with less reliance on part-time members to accomplish. This equates to firefighter and operational safety allowing us to continue our excellent service model record.
- **12)** What if the department does not receive additional funding? The department will continue to struggle with retention of current staff and recruiting replacements. Soft billing of residents may cease and revert to full collection of charges for service for residents. Staffing levels may fall to a point that on some days, for a 24-hour period, a fire station will be closed.

With the conclusion of 2022, I reflect on the year and the work the members of the department have done. We have continued to provide a high level of service for our community with the many challenges we face. This is a testament to the men and women of the fire department from the office staff to shift members.

#### **2022 IN REVIEW:**

  - 739 non-EMS and fire related calls

#### **TRAINING:**


- 1,526 hours of training

# Fire Department Receives **Power Load Cot Systems**

The department recently had a Stryker Power Load Cot System installed in each of our four ambulances. These load systems were purchased through a grant we were awarded last year by the AFG program. This grant covered 95% of the \$282,600 project with included the power load, power cot, and 5-year warranty and maintenance plan.

The load systems have proven to be a valuable tool in preventing injuries to crews and to patients, especially when working with larger patients and fewer crew members. The purchase of this equipment would never have been possible if not for being awarded this grant. In the future when we are able to replace our ambulances, these systems will be transferred to the new units.

# 2022-2023 Winter Season Snow & Ice Control



The season is coming to an end. The equipment is being cleaned for the final time and getting prepped to be put into storage until fall. Your Public Works team has done another outstanding job in keeping the streets of Canton Township safe for public travel. Here are some totals to look over so you see what goes into keeping our streets safe when snow and ice hit our area.

- Dispatched a total of 20 times this season.
- Total labor expenses \$28,174.85 (regular and overtime)
- Total equipment expenses \$60,403.80 (includes normal wear and tear, and fuel)

- Total material (salt) expense \$104,687.37 (only salt used, not what is in storage)
- Grand Total of \$193,266.02

Each season is different and so are the costs associated with them. There are also additional expenses that are not included: routine maintenance of the plows, spreaders, and vehicles after each use, cleaning of the equipment after each use, repairs when needed, and maintaining the salt storage. Currently we have approx. \$70,000.00 worth of salt stored at the Public Works Facility that is waiting to be used, which is about 1,000 tons.

It is always nice to look out your window in the morning and know that your street is passable so you can get to work or wherever you need to go. Remember that there is a lot of work that goes into prepping vehicles and equipment before the season begins, watching and waiting for the weather to hit, collaboration of multiple weather services and trying to figure out which one might be right, early mornings and late nights checking streets, and STRESS.

# Canton Township Road Levy Dollars at Work

This year we will have two paving projects being completed before July. With the extension of the 2022 project and the addition of the 2023 project, a lot of streets will resurfaced. In total, both projects came to \$1,098,483.00. The list of streets is provided on page 9. If your street is not listed, please know that it is coming.

# What is Storm Water?





Storm water is defined as the flow of water that results from precipitation which occurs immediately following a rainfall event or results from a snowmelt. When a rainfall event occurs, the precipitation is "absorbed" by the environment. The water may soak into the soil recharging groundwater supplies, while some is taken up by plants, and some is evaporated into the atmosphere. All the other water that flows or runs off the land is considered storm water. Unfortunately, as development increases, the ability of our environment to perform its natural process of "absorption" decreases. This is because the natural landscape that was once able to absorb clean storm water is covered by impervious surface. Impervious surface is simply a surface that water is unable to penetrate. Rooftops, driveways, and roads are all examples of impervious surfaces. Increased impervious surface results in both an increased amount of storm water runoff and an increased chance for pollution to enter our waterways through our storm sewer systems. This type of pollution that results from storm water runoff is called non-point source pollution.
