Zoning Updates

The Board declared the following properties as a nuisance as deemed by the Zoning Director, and ordered them abated per Ohio Revised Code 505.173 and/or 505.86 and/or 505.87 and the Canton Township Property Maintenance Code. 3141 Dueber Ave SW, 5100 Clardell Ave SW, 317-29th ST SW, 1125 Brant Ave NW and 2225 Rexdale St SW all for trash and debris. 5100 Clardell Ave SW for no deck permit.

The Board received an update from the Zoning Director on the legal process surrounding junk car removal and will consult with legal counsel on how this process could potentially be carried out in Canton Township.

Canton Township is continuing collaboration with other entities regarding a property on Prairie College that was deemed uninhabitable by the Stark County Health Department.

Public Works Department

The Public Works Department has been out on township roads for snow/ ice road maintenance on (29) occasions this winter season. A total of 1,847.5

tons of salt at a cost of approximately \$118,646 has been used, with a combined crew total of 1,129 hours.

The Public Works Director presented roads to the Board requiring probable preventative maintenance crack seal in 2021 as well as roads requiring striping.

Canton Township accepted request for qualification submissions from 10 individual firms and referred these to township legal counsel. The RFQ's are needed for architectural work required as part of Faircrest Park enhancements made possible from \$250,000 obtained after Trustees requested State of Ohio capital project funding.

The Board approved and signed the Ohio Department of Transportation 2020 Township Highway System Mileage Certification that certified the township is responsible for maintaining 97.58 miles of public roads.
