

# August 15th Meeting Highlights

# **Public Works Department**

The Board is interviewing to fill Public Works staffing needs.

Received an update that culvert pipe work and dirt fill is nearly complete at Faircrest Park. The next step will be extending the parking lot area and planting grass. These enhacements will improve parking and water drainage.

Received an update from Sol Day Harris regarding architectural drawings for the Faircrest Park Amphitheater, attached storage facility, as well as a veteran's/armed forces display area. Additionally, received initial plans for Community Center renovations. The Board instructed the firm to finalize a fee schedule to be approved and place the Faircrest plans out to bid ASAP. Canton Township applied for and was awarded a \$300,000 State of Ohio Capital grant that will be used to fund the majority of Faircrest improvements.

# Residential Yard Waste Drop- Off Site

The residential yard waste site (commercial yard waste dumping is

The operation of this site is made possible through Stark Tuscarawas Wayne Joint Recycling District grant funding in the amount of \$40,300 for 2023. As of the August billing, \$24,600 of the grant has already been spent on the hauling costs.

# **Zoning Department**

The Board approved the Fiscal Officer to to a letter to the Stark County Auditor requesting a lien on the tax duplicate for lawn maintenance/ high grass (9) parcels 1307734, 1302072, 1312424, 1309342, 1302713, 1306616, 1380055, 1380056 and 1307886 totaling: \$5,450.00

The Board approved the Fiscal Officer to to a letter to the Stark County Auditor requesting a lien on the tax duplicate for nuisance abatement on (1) parcel 1303150 totaling: \$2,055.68.

The Board declared the following properties as a nuisance as deemed by the Zoning Director, and order them abated per Ohio Revised Code 505.173 and/or 505.86 and/or 505.87. 1100 Mattie St SE for unlicensed vehicles and 920 Mattie St SE for unlicensed vehicle/ trash & debris

As of the August 15th meeting, 122 letters have been sent to notify property owners of high grass.

After obtaining a court order to perform nuisance abatement at 2901 24th St SW, the Board recently contracted with Central Ohio Recovery to tow cars and remove trash and debris. This clean- up was a 3 day process. A nuisance abatement assessment for the costs incurred will then be placed on the property's tax duplicate.

Previously this month, a clean- up was done at 2636 Georgetown Ave NE to remove trash and debris from the property. A nuisance abatement assessment for the costs incurred will then be placed on the property's tax duplicate.

## **General News**

The Board approved the third of four total Community Reinvestment Area resolutions. Approved at this meeting was the Meyers Lake Community Reinvestment Area resolution that is going to the Board of Commissioners for request of approval and then to the State of Ohio to be assigned a CRA number. Stark County Regional Planning Commission is working on the final CRA area, our 4th and final, that will then result in 100% of Canton Township residing inside of a CRA area.

Heard the hourly rate for extra Sheriff coverage in the township will increase from \$40.00 to \$50.00 effective immediately.
