


June 6th Meeting Highlights

The Board approved the following community resource organizations and

grand sponsors to have a tent/ table at Community Day: JoyFull Life, Canton Township Historical Society, Stark County Library, Canton Township Professional Firefighters, LED Transportation, Linda Reibenstein/ Colonial Title/ Guaranteed Title, Canton South Athletics, Canton South Athletic Booster Club, Canton South Youth Sports (soccer, cheer, football), Project Rebuild, BridgePoint Community Services, Stark Parks, Canton Township Administration and Fire Department.

<u>Fire Department</u>

Chief Smith update the Board on a \$10,000 Healing Communities grant received for training, equipment, and supplies related to opioid addiction harm reduction and care linkage.

Chief Smith discussed with the Board upcoming promotional assessments for Captain and Lieutenant positions.

Approved the installation of the Community Center/ Fire Administration access control system that's better positioned to accommodate facility rentals in the future.

Approved the purchase of materials to improve landscaping around the fire stations.

Approved purchase of the simulator to enhance CPR training and outreach with other organizations and departments. This simulator will be capable of duplicating the dashboard of various brands of life savings devices that may be in use around the industry.

The Board approved the monthly fee paid to Cindy Annen, CPR Coordinator to be increased from \$600 to \$800 effective June 1st.

The Board approved a Memorandum of Understanding that has been approved by union membership and will provide bargaining unit members of CTFD with a 10% increase in hourly pay effective 05/21/23, with future sustainable financial support provided by the community due to passage of the recent fire levy. This increase begins to position the department on a more equitable pay scale as other departments within the immediate area who have similar financial means to support operations.

Public Works Department

2022 and 2023 Paving Programs Update:

The 2022 paving project which was extended until 2023 is now complete. A total of 2.9 miles of roads were paved at the cost of \$628,488.00. The 2023 paving project in conjunction with the Canton City Water Line Extension Project is also now complete. A total of 3.2 miles of roads were paved at a cost of \$469,995.00.

Residential Yard Waste Drop- Off Site


The residential yard waste site (commercial yard waste dumping is **prohibited**) reopened for the season on April 1st. It is currently open on Wednesdays, Saturdays, and Sundays from 9am-7pm. The hauling of the yard waste is handled by Bull Country Compost LLC with a cost of \$175 per dumpster (\$25 per dumpster increase this year). The operation of this site is made possible through Stark Tuscarawas Wayne Joint Recycling District grant funding in the amount of \$40,300 for 2023. As of the May billing, \$14,275 of the grant has already been spent on the hauling costs. The yard waste site is pacing at a much higher volume and cost vs. the same time last year. If the this pace continues, the Board may potentially look to reduce site hours or close the site earlier than last year.

Zoning Department

As of the June 6th meeting, 67 letters have been sent to notify property owners of high grass.

The Board approved the Fiscal Officer to to a letter to the Stark County Auditor requesting a lien on the tax duplicate for lawn maintenance/ high grass on (21) parcels: 1301441, 1307798, 1302727, 1302726, 1307886, 1309342, 1301591, 1307480, 1313644, 1380055, 1380056, 1305099, 1303096, 1304876, 1304875, 1305244, 1302764, 1305576, 1312336, 1307061 and 1307062 totaling: \$10,450.00.

The Board declared the following properties as a nuisance as deemed by the Zoning Director, and ordered them abated per Ohio Revised Code 505.173 and/ or 505.86 and or 505.87- 4006 12th St NW for an unsecured structure and 2636 Georgetown Rd NE for trash and debris.

The Board discussed the legal process and expenses involved in removing junk vehicles.

The Board of Zoning Appeals will conduct a public hearing at the Administration Office on Monday, June 12th at 7:00 pm.

The Board approved to waive an application fee for Canton Local Schools for an accessory building in the amount of \$119.20.

Transient Vendor Regulations

- **COMING SOON!** Look for information coming soon to list your address on the Do Not Knock Registry
- Each person representing a company soliciting in Canton Township is required to obtain a background check from the Stark County Sheriff's Office and register with the township
- Updates to regulations limit times and days registered Transient Vendors can solicit
- Penalties may apply for those in violation to these regulations
- See the Canton Township website for Resolution 06-02-23 for details

(This does not apply to entities exempted from taxation under ORC Sec 5709.04 or licensed under ORC Chapter 4707)



Stark County Overdose Awareness Day is August 12

In 2022, approximately 156 Stark County residents were among the 4,984plus Ohioans who lost their lives to overdose. That's why the Stark Overdose Awareness Committee will bring people from all backgrounds together to unite under a common cause: Calling attention to the ongoing overdose crisis and remembering those affected without shame or stigma. The committee will host an Overdose Awareness Day event on Saturday, August 12 from 9 a.m.-12 p.m. at Centennial Plaza in downtown Canton. Canton Township residents are invited to attend. Activities and resources will be available for youth, older adults, Veterans and women. Some of the activities being planned for the morning include:

• Drum therapy from Warrior Beat, a non-profit charity that helps military veterans who suffer from PTSD, anxiety, depression, thoughts of self-harm and suicide, substance abuse and other mental and physical challenges

 \cdot Yoga for 12 Step Recovery, which combines the practical tools of 12 step programs and cognitive addiction methodologies with the ancient art and science of yoga, neuroscience and trauma healing

· Free haircuts

• Health services from the Stark County Health Department's mobile integrated care unit "Driving Towards A Healthy Community"

Naloxone distribution provided by Canton City Public Health

· Linkage to care provided by AVO Behavioral Health and Recovery Center

The Stark Overdose Awareness Committee is made up of local and regional agencies including AVO Behavioral Health and Recovery, Canton City Public Health, HEALing Communities Study, Let's Get Healthy Cleveland, Massillon City Health Department, Metamor5sis, Millennium Health, Stark NAACP, OhioCAN (Change Addiction Now), Stark County Health Department, Stark County Mental Health & Addiction Recovery, and Veterans Services Commission.
