Public Works Department

Karvo (vendor selected through bid process) began the grind/ pave resurfacing project on township roads.

The Board approved to sell a Jet Lathe machine on GovDeals.com with a reserve of \$3,000.

The Board approved a resolution to vacate a portion on Moore Ave SE .

The Board received an update the backup power generator work at the admin/Public Work building will be finished up middle of September.

Since the last Board meeting, the following pavilions have been rented: Faircrest A- 4x's, Community Park- 2x's and Faircrest B- 1x.

The Canton Township Board of Trustees received notification from the Stark County Prosecutor's Office charges have been filed against individuals who, following completion of investigation by the Stark County Sheriff's Office, were alleged to have vandalized or participated in some manner as part of the vandalization of Canton Township's Faircrest Park. This item currently awaits attention within the court system.

Zoning Department

The Board declared the following properties as a nuisance as deemed by the Zoning Director, and order them abated per Ohio Revised Code 505.173 and/or 505.86 and/or 505.87.4. 512 Marietta Ave SE and 2nd St SE for trash and debris.

The Board approved the Fiscal Officer to sign letter to Stark County Auditor requesting a lien on the tax duplicate for lawn maintenance/high grass nuisance assessment on (17) 1301441, 1380055, 1380056, 1307232, 1307233, 1307234, 1307235, 10001856, 10001854, 10001857, 1307734, 1308052, 1307061, 1303513, 1303262, 1304740, 1304739 parcels totaling \$8,250.00.

The Zoning Commission will conduct a public hearing on Monday, Sept. 23rd at 6pm to consider a text amendment to the Canton Township Zoning Resolution regarding the addition of R-4 Low Density Multi- Family and R-5 High Density Multi- Family as a permitted use in B-1 Suburban Office and Limited Business District, B-2 Neighborhood Business District, and B-3 Commercial Business District. The Board of Trustees will conduct a public hearing on Tuesday, October 1st at 5:30pm to consider the recommendation from Stark County Regional Planning and Zoning Commission. Proposed amendments are available for public viewing Mon-Fri from 8am-3pm at the Administration Office.

General News

The Board received an update from the Fiscal Officer indicating he is in the process of interviewing for an administrative assistant to the fiscal officer position. This position replaces the Assistant Fiscal Officer position that will soon be vacated.

Below is notice that will be published in the Canton Repository:

The Canton Township Board of Trustees will have the question of whether Canton Township should become a Home Rule Township on the ballot for the upcoming November 5, 2024 General Election.

Approval allows Canton Township to pass Home Rule resolution legislation addressing Township matters that non-Home Rule, or statutory townships, cannot. Non-exhaustive examples of such legislation are animal control, transient vendors and noise control. Home Rule Townships may also be exempt from certain state legislation with the ability to decide certain state legislation issues for themselves. Non-exhaustive examples include certain state zoning and economic development legislation. Home Rule approval does not give the Board of Trustees the ability to levy any additional tax without the approval of the voters and there is no additional tax. Canton Township under Home Rule would remain a three-person Board of Trustees and continue with a very similar structure to what is currently in place.
