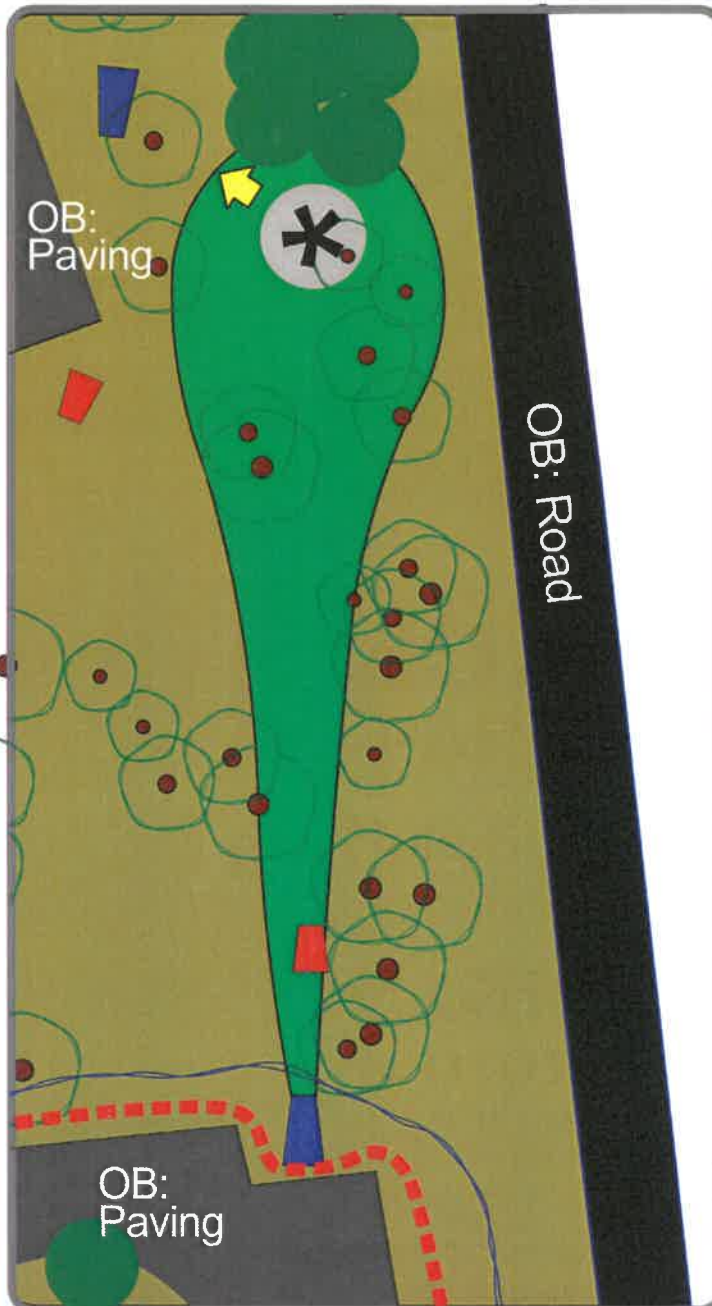

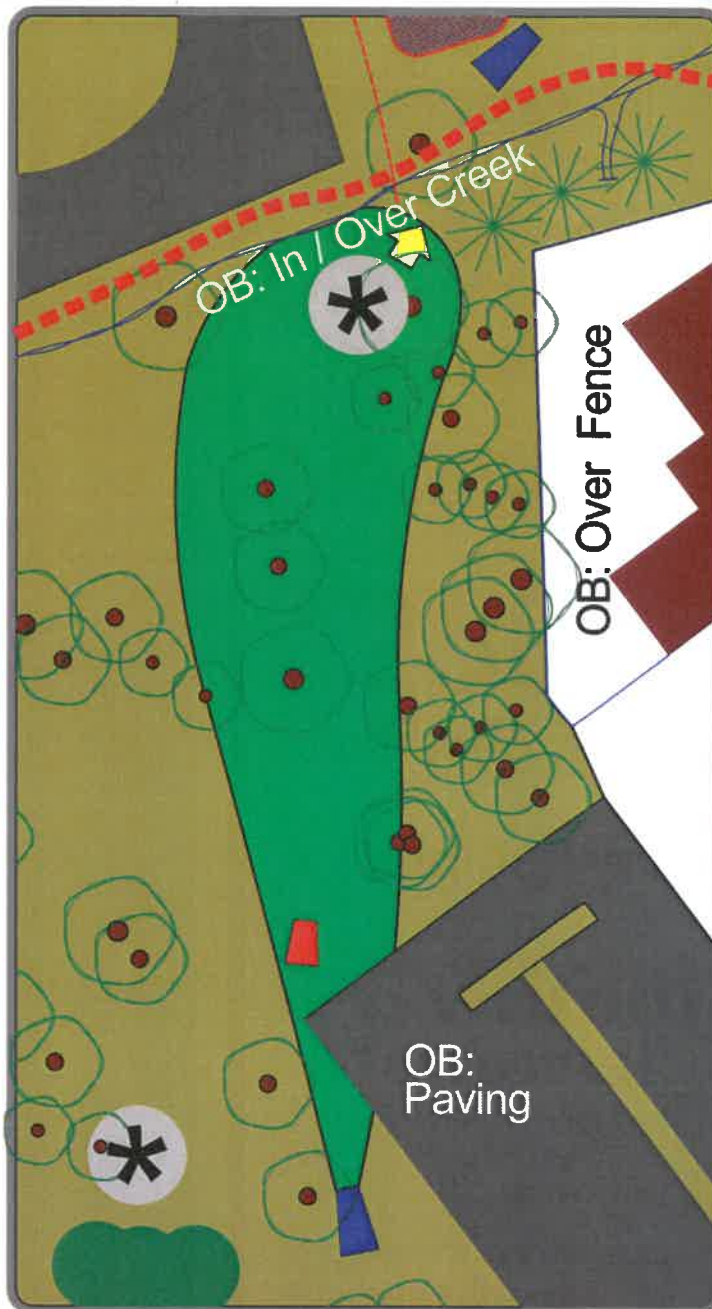

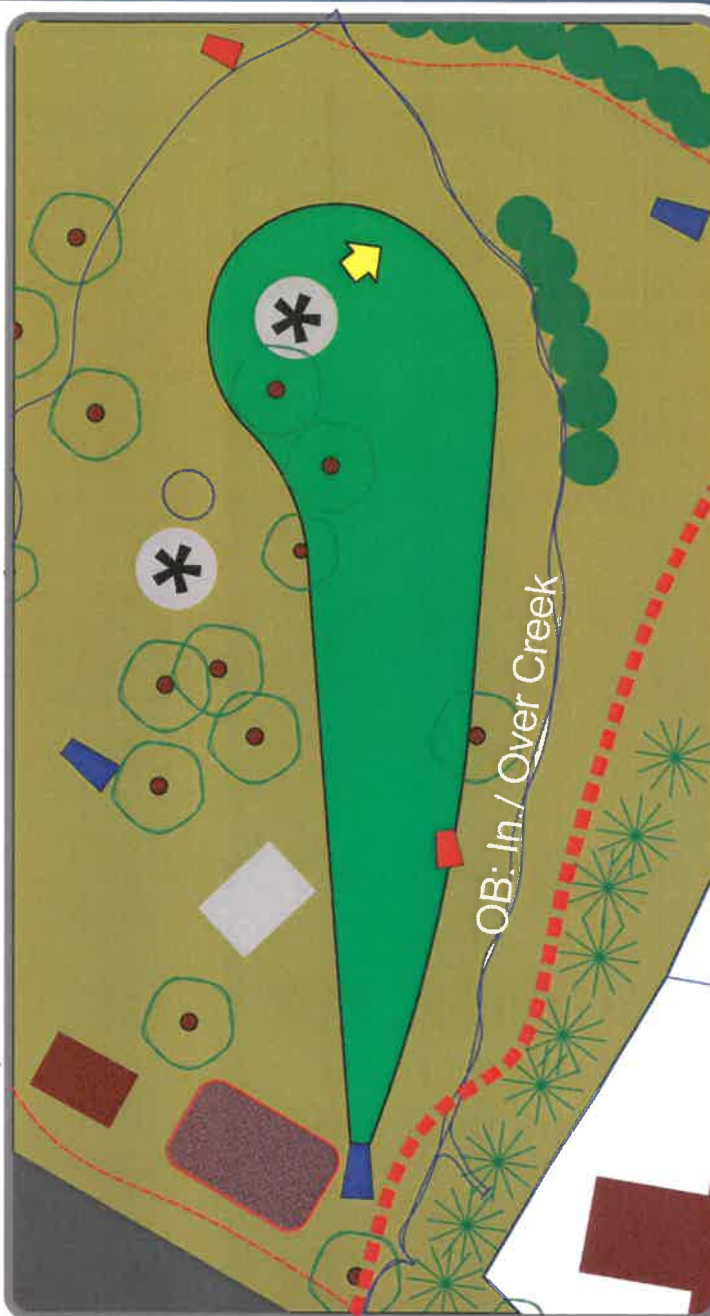

803.09 Out-of-Bounds
A disc is considered out-of bounds
when it comes to rest and is clearly
and *completely surrounded* by the out-
of-bounds area... The Player... shall
receive 1 penalty throw. (Play from
where it was last in-bounds or retee if
first shot or from the Drop Zone)

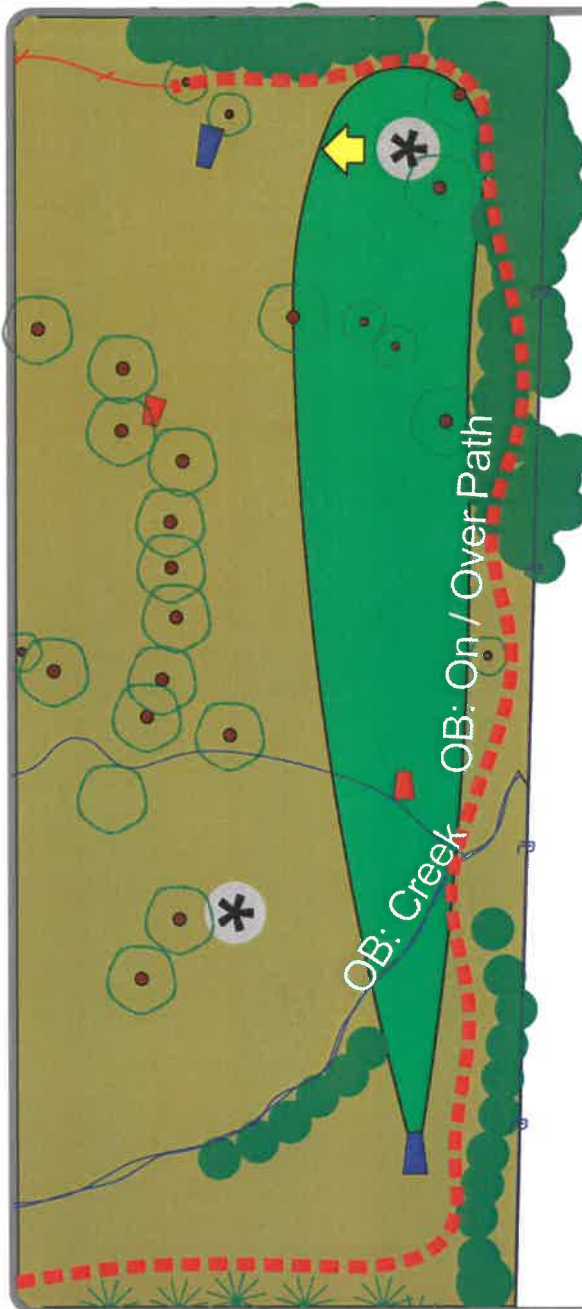

801.03: Excessive Time
A maximum of 30 seconds is allowed to each player to make a throw after the previous player has thrown, the player has arrived at the disc, and the playing area is clear... First time is a warning, subsequent times in the same round is one penalty throw.

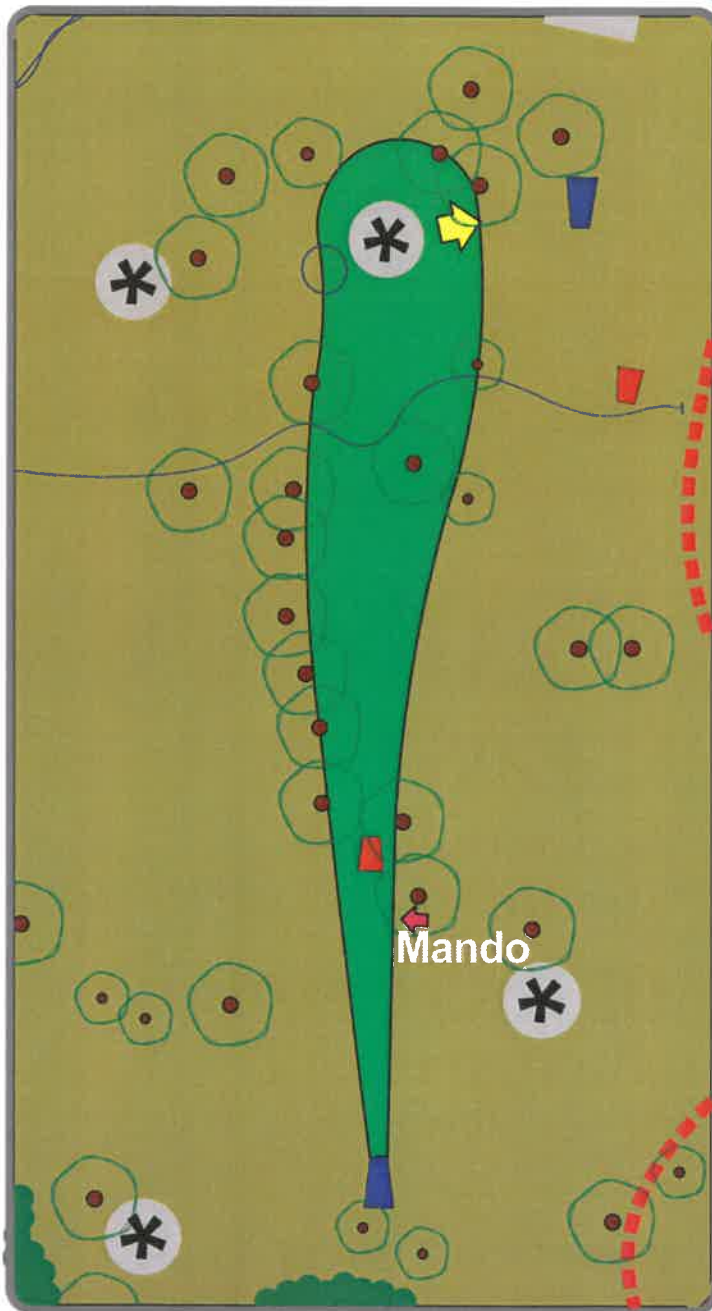

893.04.C Stance:
Any throw from within 10 meters
(32'-6") or less is considered a putt.
A follow through after the putt that
causes the thrower to make any
supporting point closer to the hole
than the rear edge of the marker disc
constitutes a falling putt & is a stance
violation.

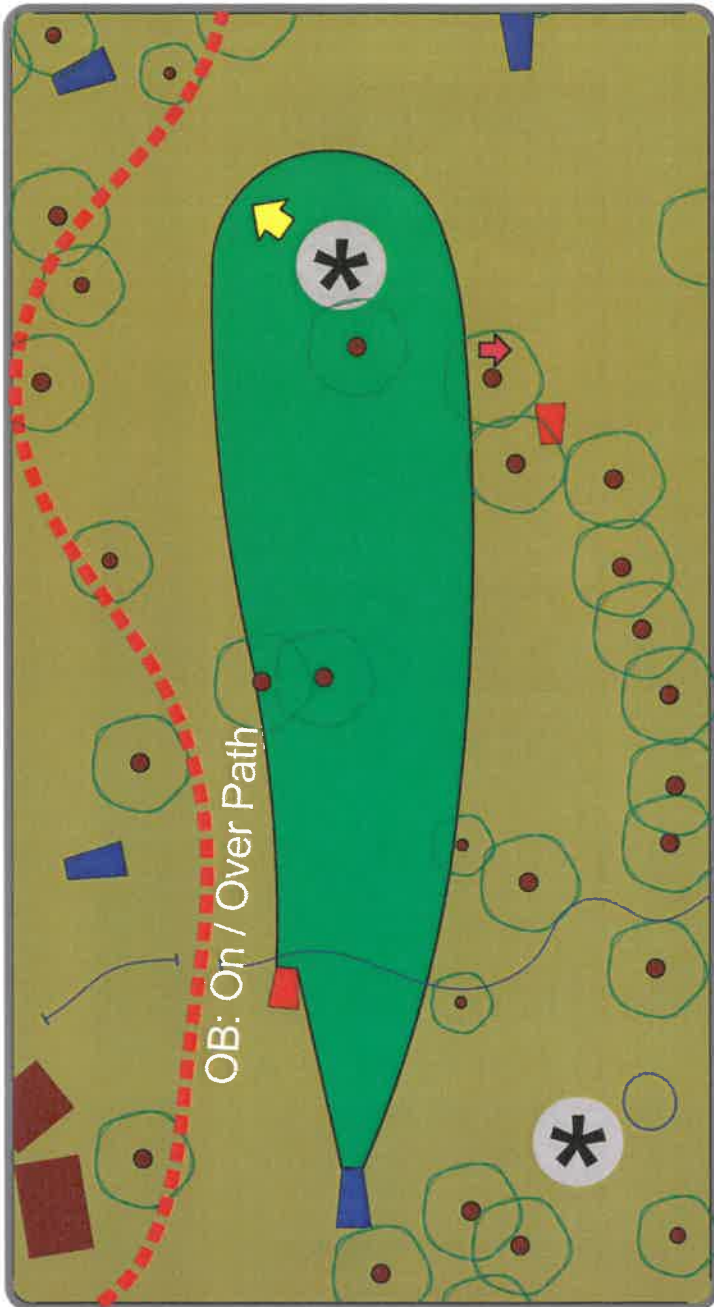

803.11: Lost Disc - Part A
... A disc shall be declared lost if the player cannot locate it within three minutes after arriving at the spot where it was last seen... Someone must note when timing begins... All players in the group must assist in searching for the disc the full 3 minutes...

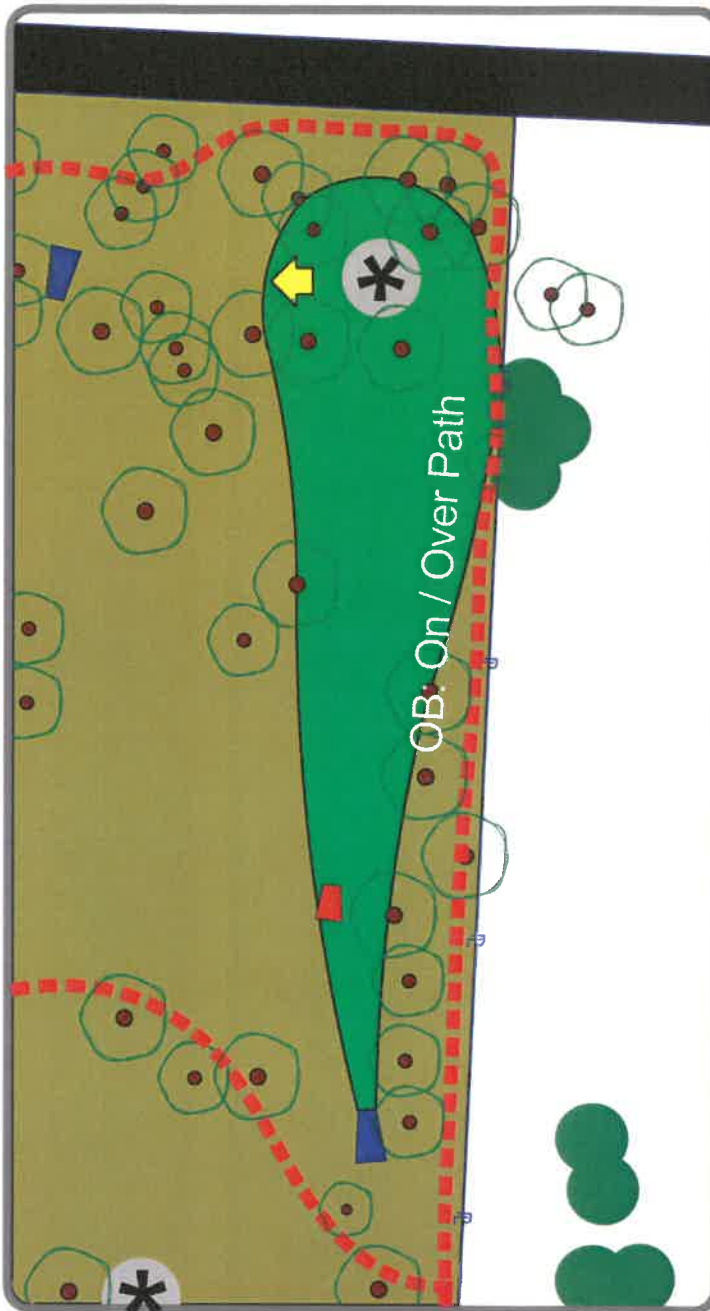

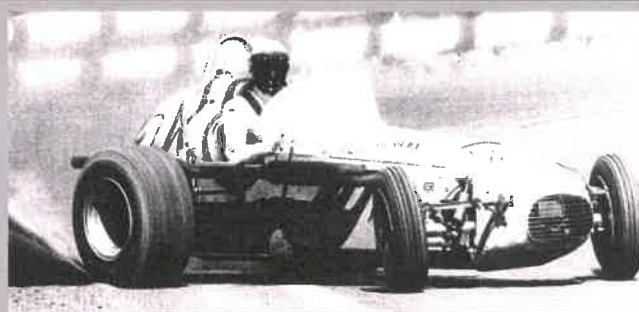
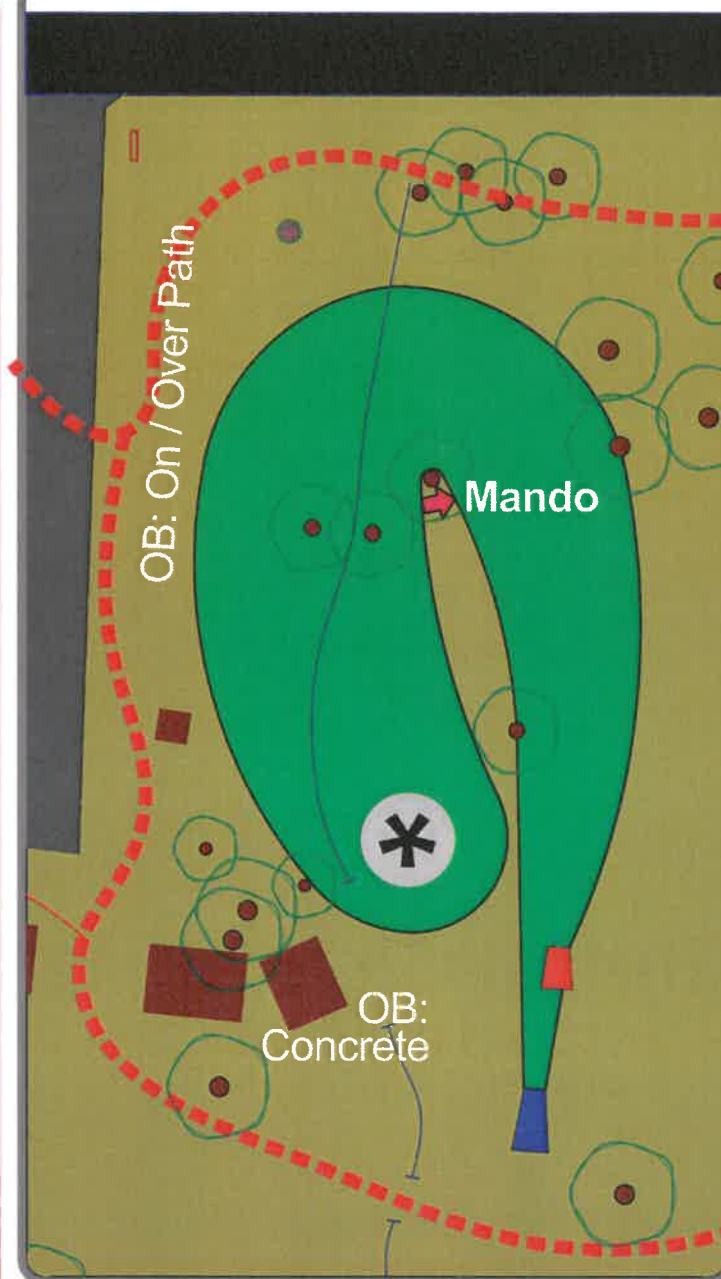
