

#### **Yard Waste Updates**

Year-to-date yard waste card totals are 469 Canton Township, 33 Pike Township, and 12 Village of East Sparta. Year-to-date income is \$62,871.69 (includes one time set-up grant) and year-to-date expenses total \$54,265.25. Based off what has been the 2024 monthly container run rate and a heavier than anticipated drop off volume, it is projected costs to operate the yard

waste site will exceed revenue from residential pass sales by end of October. Expenses will be closely monitored as the Board of Trustees intend for the yard waste site to operate as a user funded service not supported by any other funding sources. As the community is aware, prior grant funding that's paid for the yard waste site ended at conclusion of the 2023 season.
