

March 18th Meeting Highlights

Fire Department

The Board approved the purchase of rope and rescue gear at a cost not to exceed \$10,000. The purchase is to fulfill the equipment obligation as part of the StarkSORT (special operations response team).

The Fire Department will take part in a Full-Scale Active Shooter Drill in conjunction with the Stark County Sheriff Department at Canton South Middle School on Friday, March 21st.

Public Works Department

The May 6th ballot will have a road renewal levy. *NOT A NEW TAX. NOT AN INCREASE*. The Road Levy is the source of funding for ongoing road resurfacing. If the levy is not renewed, road resurfacing will not continue. This is a 2.9 mil, five-year renewal levy, commencing in 2025. This would CONTINUE to cost owner of \$100,000 home \$50.91 per year and generate \$892,000 per year.

The Public Works Director provided an update on winter roadway maintenance for the season. So far the Public Works Department has been out treating roadways for snow and ice a total of 47 times. To date labor, equipment, fuel and salt expenses are approximately \$363,000.

This winter weather season the township experienced a significant increase in weather events which impacted overall costs verses the last two seasons. Below is an overview of the last three years of winter roadway maintenance totals:

- 24/25 season- treated roadways for snow and ice a tot al of 47 times. Labor, equipment, fuel and salt expenses are approximately \$363,000.
- 23/24 season- treated roadways for snow and ice a tot al of 22 times. Labor, equipment, fuel and salt expenses are approximately \$186,000.
- 22/23 season- treated roadways for snow and ice a total of 20 times.

Labor, equipment, fuel and salt expenses are approximately \$193,000.

The Board approves the Public Works Director to sign the 2024 NPDES Small MS4 general permit annual report and submit to the Ohio EPA.

The Board approved a 30-day contract extension for the sanitary sewer pump station with Bachtel excavating.

Faircrest St SW at Cleveland Ave SW will be closed the week of March 24th for water line connection.

Township Parks

The Board approved the use of township ballfields to the CS Youth Baseball and Lady Wildcat Youth Softball:

- Mikunda and Abbott fields for 6U, 10U, and 14U softball
- Hamilton and Hayhurst fields for 10U and 12U baseball

Canton Township Community Park will open for the season on Monday, March 24th.

The Board accepted \$200 in receipts for park pavilion rental.

The Public Works Director updated the Board that concrete work at Faircrest park will be completed shortly for stage and storage building improvements.

The Board approved the purchase of new playground equipment for Faircrest Park in the amount of \$236,687 to be purchased and installed utilizing State of Ohio Capital Grant dollars.


