Fire Department News

The Board approved the Fiscal Officer to sign the Real Estate Purchase Agreement, purchase price of \$106,000.00, with G3P, LLC, for the township owned property located at 3520 Sherman Church Ave SW, Canton, OH with said Purchase Agreement having been reviewed and approved by township legal counsel.

Road Department News

The Board approved Resolution 07-04-20 "A RESOLUTION TO POST MULTIWAY "STOP SIGNS" AT THE INTERSECTION OF SHERER AVENUE SW AND PRAIRIE COLLEGE SW." The additional stop signs are being added as a result of a recommendation resulting from a recent safety survey conducted by the Stark County Engineer's Office.

The Board approved the Public Works Director to hire Jared Perez as a part-time seasonal road crew worker.

The speed sign trailer is operational and currently deployed on 39th St SW and Springvale Ave SW. Residents may contact the road office with speeding concerns and use of the trailer in their area.
