The Board approved a new dispatch contract with the Stark County Sherriff's Department which included a 1% cost increase.

Approved contracting with Eric Williams of The Law Office of Eric J. Williams, LLC for additional legal counsel to Canton Township.

## ***Fire Department***

The Board approved the Fire Chief to apply for the SAFER grant in the amount of \$1,958,728 for three years with requirement of 0% match on Canton Township's part to bolster staffing levels by as many as 9 full time members.

A change order was approved for the new engine under build now that is due for delivery in June 2022.

## **Public Works Department**

The Board of Trustees expressed their appreciation to the Public Works team for efforts during the recent snowstorm and acknowledged the multiple resident compliments and positive messages received.

Approved the updated Canton Township Application for Permit to Excavate within Township Roads or Road Right of Ways.

Approved the Public Works Director to sign the Memorandum of Understanding between Canton Township and Stark Soil & Water Conservation District for Technical Assistance. This contract will be for a period of 2 years which expires in 2024.

The Board approved the update 2022 Park Pavilion Rental Contract.
